



# Isle of Man Natural History and Antiquarian Society

## Spring 2018 newsletter

Welcome to our Spring 2018 newsletter. Enclosed is the programme card for the forthcoming summer excursions; this newsletter is intended to give a summary of some of the activities of the Society during the last six months, and other selected topics of interest to members.

### ***Building Conservation and Planning***

The Society made a submission to the 'Planning Review Consultation', a copy of our submission (25 pages of responses to 52 pages of questions) can be read on our web site. Almost everybody who tried to tackle this 'Consultation' found it hard-going or a challenge, and it was variously described as, at best, "a mess" and "confused". We did ask for public meetings to clarify the issues whilst the Consultation was open so those on the Island could respond properly – this was not possible but there is still a chance of public meetings prior to legislation being drafted.

We are pleased to hear DEFA has appointed a Registered Buildings Officer, who will be in-post from the 1<sup>st</sup> of May. However, the Registered Buildings Officer is just a single post – we used to have a Conservation Officer and a support organisation – and even they couldn't keep up with their caseload. Whilst there are more than enough outstanding Registration proposals to keep the new Registered Buildings Officer occupied, we are concerned and hope the pendulum doesn't swing too far, and the Department restarts the critical provision of advice – to planners, developers and owners of the 99.99% of un-Registered buildings.

We are also heartened that, following our campaign, it appears that DEFA Planning and Building Control are also trying to make more of the registration files eventually available on-line and transparently, just like conventional planning applications. We are aware that there is an opportunity and hopefully an appetite for change and we will do all we can to assist with that.

Central to our strategy is raising public awareness of our built heritage, and a major component of this is our fortnightly double-page Buildings at Risk article series in the *Isle of Man Examiner*, which we publish under the Alliance for Building Conservation (ABC). We originally envisaged 'just a few' articles to raise the profile of the plight of our built heritage leading up to the General Election in autumn 2016, but we've managed to keep going and article number 50 will appear in a few weeks. ### ***Douglas Bay Horse Tram Stables***

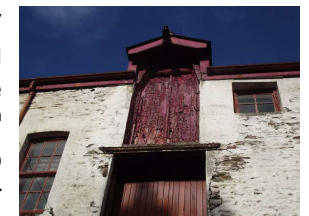
Following our excursion to Summerhill last summer, IoMNHAS amongst other organisations and individuals have been encouraging DEFA to enter the Summerhill Douglas Bay horse tram stables on the list of Registered Buildings. The stables and their frontage, Tramway Terrace, represent what is believed to be a unique example of an artisan designed, working stable yard and blacksmiths.



We were delighted to receive the news in February 2018 that DEFA have officially proposed to register the lower (older, in part Thomas Lightfoot designed) stables, Tramway Terrace and blacksmiths. We believe Tramway Terrace - albeit in poor condition internally - could be refashioned to maintain its frontage but incorporate good staff accommodation, visitor facilities and accommodation for working experience on the transport system and an apprentice.



The proposal to register is only the first stage in the Registration process. With sufficient support and knowledge it may be followed by the Registration of the buildings. However Registration may be challenged by an application to deregister which like a planning application may be taken to appeal. While the deadline to make comment on the proposal to Register was 28<sup>th</sup> February 2018, any application to deregister must also be advertised. We would hope you will give your support in writing to the DEFA for their Registration.



### ***Fairs and Festivals***

Last year, we continued to develop our interactive fair stall. In addition to the Tynwald Fair, we accepted an invitation to participate in the Food and Drink Festival, which – with the help of our members - was a great hit, so much so we were immediately invited back for the tenth Food and Drink Festival this coming September.

This year, your Committee has also accepted an invitation to the Southern Agricultural Show, where we will be running our stall and activities in the organisers' Heritage Tent.

So, this season (2018) we will be at the Tynwald Fair (5<sup>th</sup> July), the Southern Show (28<sup>th</sup> and 29<sup>th</sup> July), and the Food and Drink Festival (15<sup>th</sup> and 16<sup>th</sup> September). ### ***Isle of Man Studies (Proceedings of IoMNHAS) / Hon. Editor***

The Society and the Hon. Editor regret the delay in publishing volume XV of *Isle of Man Studies (Proceedings IoMNHAS)*, copies were despatched to subscribing members in December 2017 and are still available for Life Members and others to purchase.

Although the first three volumes under the *Isle of Man Studies* title targeted annual publication, the Committee recognises the burden this places on the Hon. Editor and it is likely that we will revert to biennial publication.

In preparation for recruitment of a new Hon. Editor, the Committee has reviewed and documented the requirements for the journal, based around the goals: (i) to comply with the Society's rule 16 "*The papers read before the Society, or abstracts of them, may be published in the Proceedings or other publications of the Society*", and (ii) to comply with the Society's aim of the "*advancement of knowledge of Natural History and Human History and Cultural Development, especially in the Isle of Man*".

As no candidate had come forward before the AGM, the Committee hopes to find a suitable candidate and fill the vacancy under rule 9 (filling vacancies during the year).
